**Your Tissue Products – Personal Data**

You/your medical doctor reached out to LifeNet Health Europe GmbH with the aim to obtain either one or several Tissue Products from us in order to use such Tissue Products as part of your medical treatment.

To ensure that we only provide you and your medical doctor with finest quality Tissue Products, verified to be suitable for you and your medical treatment, your medical director intends to make personal data about you available to us that may include the following:

- **Identification data:** name and surname, date of birth, medical record number;
- **Medical data:** gender, age, body height and weight, blood type, medical outcome and treatment goal regarding the Tissue Products, X-ray images and Magnetic Resonance Imaging (MRI).

We will only process (i) your **medical data** for evaluating whether we have Tissue Products suitable for you/your medical treatment available, and (ii) your **identification data** for providing you/your medical doctor with Tissue Products in compliance with Article 6 para. 1 lit. a, Article 9 para. 2 lit. a General Data Protection Regulation (GDPR) and our legal obligation to ensure the traceability of our Tissue Products. For that reason we may also transfer your **medical data** to the LifeNet Health Global Headquarters in Virginia Beach, Virginia, USA, with which LifeNet Health Europe GmbH has entered into a standard contractual clause for data transfers as issued by the European Commission. We will store your personal data only as long as absolutely necessary for fulfilling our aforementioned contractual and legal obligations pursuant to the applicable Austrian Tissue Safety Act; *Gewebesicherheitsgesetz*. If for some reason the order is cancelled before we provide a Tissue Product to your doctor, we will delete your personal data.

You have the right to request access to and rectification or erasure of your personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability, and to provide instructions as to the situation of your personal data in case of death. You further have the right to lodge a complaint with the data protection authority of your country.

*Since we/LifeNet Health Europe GmbH will need to process your personal data as outlined above, we kindly ask you to complete this Patient Consent Form as follows:*

**Consent Declaration**

For that purpose, I expressly consent further that LifeNet Health Europe GmbH transfers my medical data to LifeNet Health Global Headquarters in Virginia Beach, Virginia, USA.

I acknowledge that I can revoke my consent (in whole or in part) and exercise my rights under applicable data protection laws at any time and free of cost via letter to LifeNet Health Europe GmbH, Dietrichgasse 25, 1030 Vienna, Austria or via email to [eu\\_service@lifenethealth.eu](mailto:eu_service@lifenethealth.eu). This does not affect the validity of my consent until its revocation. I understand that a revocation of my consent (in whole or in part) and/or the exercise of certain rights under applicable data protection laws may make it impossible for LifeNet Health to find a suitable allograft bio-implant solution for me/my medical treatment and that LifeNet Health Europe GmbH cannot be made liable for any non-delivery of Tissue Products.
